A. Introduction

§ 1 Object and Scope

¹ This program regulation contains the implementation provisions for the Framework Ordinance for the Double Degree Master's Programs of the Faculty of Law of the University of Zurich and the Foreign Partner Faculties dated 1 March 2021.

² This program regulation applies to the following double degree study programs:

- a. The study program Law
- b. The study program International and Comparative Law

³ The standard curricula and arrangements are detailed in the Appendices.

⁴ Details of special arrangements with the partner faculties are also provided in the Appendices.

B. Studies

1. Admission

§ 2 Admission to the Double Degree Program

¹ The following academic degrees allow admission to the double degree Master's program without any conditions or additional requirements:

- a. Bachelor of Law from the University of Zurich
- b. Bachelor of Law from another Swiss university

² The following applies to graduates of a foreign Bachelor of Law program/holders of an equivalent degree in law from a state-accredited university or other further education institution according to the Higher Education Act (HEdA):

- a. They can be admitted to the double degree Master's program with conditions and/or additional requirements totaling a maximum of 60 ECTS credits
- b. The decision is taken by a faculty-internal admissions committee on the basis of an examination of the applicant's documents.

³ If the applicant does not have a degree as defined in paragraph 1 or 2, he or she cannot be admitted.

§ 3 Selection Procedure

¹ The selection procedure for participation in a double degree Master's program is conducted once per academic year. It generally takes place at the start of the Fall Semester.

² The responsible Steering Committee of the Faculty of Law selects the students according to their suitability. It assesses their suitability on the basis of the application documents. A selection interview may also be conducted with the students.

³ The following are key to the assessment of suitability:

- a. Academic achievements
- b. Knowledge of the language of instruction



- c. Specific motivation to study
- d. Additional qualifications relevant to studies
- e. The special admission requirements of the partner faculties

2. Study Program Law

§ 4 Structure

The German-language double degree study program Law comprises a total of 60 ECTS credits and consists of:

- a. A compulsory Master's thesis module worth 12 ECTS credits
- b. A core elective module worth 6 ECTS credits
- c. Further law modules worth 42 ECTS credits²

§ 5 Failed Attempts and Repetition of Modules

¹ The Master's thesis can be repeated twice.

² A joint maximum limit of eight failed attempts applies to the core elective module and the elective modules.

³ As long as the maximum number of failed attempts has not been exceeded, the core elective and elective modules can be repeated as often as students wish, provided that the modules are offered again. The following modules can be repeated twice:

- a. Zivilverfahrensrecht (Civil Procedure Law)
- b. Handels- und Wirtschaftsrecht II (Trade and Business Law II)
- c. Steuerrecht I (Tax Law I)
- d. Öffentliches Recht: Vertiefungen (Public Law: Advanced Topics)

⁴ As long as the maximum number of failed attempts has not been exceeded, core elective modules can be substituted with other core elective modules and elective modules with other elective modules.

3. Study Program International and Comparative Law

§ 6 Structure²

¹ The English-language double degree study program International and Comparative Law comprises a total of 60 ECTS credits and consists of:

- a. Compulsory modules worth 18 ECTS credits, including the Master's thesis worth 12 ECTS credits
- b. Core elective modules totaling 36 ECTS credits
- c. Additional Faculty of Law core elective or elective modules worth 6 ECTS credits



² Students with a Bachelor of Law degree from a Swiss university are deemed to have already completed the compulsory Introduction to Swiss Law module at the start of their study program. Instead, they must complete a further Faculty of Law module of their choice worth 6 ECTS credits.

§ 7 Failed Attempts and Repetition of Modules²

¹ Compulsory modules can be repeated twice.

² A joint maximum limit of eight failed attempts applies to the core elective and elective modules.

³ As long as the maximum number of failed attempts has not been exceeded, the individual core elective and elective modules can be repeated as often as students wish, provided that the modules are offered again. Modules pursuant to § 6 para. 2 letter b can be substituted with modules from the corresponding module group, modules pursuant to § 6 para. 2 letter c with other core elective or elective law modules.

4. Studies and Disability

§ 8 Admission and Matriculation

¹ Applications for accommodation measures must be submitted to the Study Dean's Office each semester. The deadlines for the submission of the applications are published on the Faculty of Law website.

² The Vice Dean of Studies decides which accommodation measures will be granted and what form they will take, taking into account the measures recommended by the Disability Office.

³ Accommodation measures can be granted for more than one semester in justified cases.

5. Modules and Assessments

5.1 Booking and Canceling Modules and Deadlines

§ 9 Booking and Canceling Modules

¹ Module bookings and cancellations must be done via UZH's digital infrastructure.

² Bookings and cancellations are binding.

§ 10 Module Requirements

Module requirements which must be met before booking a module may be defined, such as the successful completion of certain modules or the acquisition of certain knowledge.

§ 11 Deadlines

The deadlines for each module are published in the course catalogue.

§ 12 Different Booking Processes

Different booking processes may also be applied and will be published in the course catalogue.



5.2 Inability to Attend Assessments or Incomplete Assessment

§ 13 Reasons for Inability to Attend and Factors that Could Detrimentally Affect a Student's Performance

¹ Reasons for inability to attend in the sense of § 2 para. 2 RVO RWF DD in conjunction with § 24 para. 1 and 2 RVO RWF which render completion of the assessment impossible or unreasonable include in particular:

- a. Sickness and accident, provided that they are evidenced by a medical certificate
- b. Deaths of close relatives, provided that they are evidenced by a death certificate or death notice
- c. Traffic delays, provided that they are evidenced by confirmations from the transport company involved

² Assessments that have already been completed cannot be canceled if the cancellation is based on factors having a detrimental effect on the student's performance that were known or discernible before or during the assessment.

§ 14 Withdrawal Procedure in the Event of Inability to Attend Assessments or Incomplete Assessment

In the event of inability to attend or incomplete assessment, the request to cancel the assessment and the appropriate evidence must be submitted to UZH via the digital infrastructure.

§ 15 Medical Certificate

¹ Medical certificates relating to reasons for inability to attend in the sense of § 13 para. 1 letter a must be issued by a doctor with the requisite license to practice.

² The certificate must certify that the approval of the request to cancel the assessment in accordance with § 14 is essential for medical reasons.

5.3 Type of Assessments

§ 16 Announcement

The type of assessment for a module will be announced no later than four weeks after the deadline for cancellation elapsed.

5.4 Examinations

§ 17 Examination Periods

¹ The Faculty of Law defines the examination periods. Examinations for individual modules may also take place outside the examination periods.

² The examination periods are published on the Faculty of Law website.



§ 18 Examination Dates

¹ The examinations are held in the semester in which the module in question is offered; in the case of two-semester modules, they are held in the second semester.

² Failed examinations for compulsory modules can be repeated in the following semester. Repeat examinations are written or oral. Examinations can also be repeated if they are not taken for reasons defined in § 13; the procedure to be followed in this case is governed by §§ 13 ff.

³ The date of the examination will be announced no later than five weeks before the expiry of the cancellation period.

§ 19 Duration of Examinations

¹ Oral examinations take at least 15 minutes.

² Written examinations take at least one hour.

5.5 Papers

§ 20 Plagiarism Statement

By submitting a paper, the author confirms that he or she has written the work independently and has not already submitted it for assessment in the past. Direct use or imitation of texts from works by other authors (plagiarism) without acknowledgment of the source and multiple use of one's own work are not permitted.

§ 21 Master's Thesis

¹ Faculty members, professor emerita, adjunct professors, and privatdozenten can be appointed as supervisors. In addition, members of the teaching staff may also supervise Master's theses in individual cases, with the consent of the subject group of the subject area in question.

² The Master's thesis for the German-language double degree study program must be written in German.

³ The Master's thesis for the English-language double degree study program must be written in English.

⁴ The supervisor determines whether an inadequate Master's thesis can be improved and what the requirements are for this.

⁵ The further arrangements are defined in a fact sheet.

6. Changes, Exclusion from Studies, and Bans

§ 22 Changing to Another Study or Degree Program

Students may change to a different study or degree program if there are no obstacles to admission or the successful completion of the degree in light of the assessments and failed attempts completed to date.



§ 23 Ban

¹Definitive exclusion from a double degree study program from the Faculty of Law has the effect of banning the student from all study programs in which he or she will no longer be able to successfully obtain a degree.

²Definitive exclusion from studies because the student has exceeded the maximum duration of studies in accordance with § 13 RVO DD has the effect of banning him or her from all study programs of the double degree Master's programs.

7. Forfeiture and Transfer of Credit Earned for Coursework

§ 24 Forfeiture

Coursework can be transferred within ten years of the semester in which it was completed. After that, it is deemed to have been forfeited.

§ 25 Transfer of Credit for Coursework Completed at the Partner Faculty

¹Coursework completed at the partner faculty and taken into account in the degree by means of a general transfer will be shown in the transcript of records as "pass/fail".

²The credit will be transferred once the student has made a corresponding request and submitted the transcript of records from the partner faculty.

C. Final and Transitional Provisions

I. Repeal of existing legislation

§ 26 Repeal of existing legislation

The following program regulations are rescinded by 31 July 2021:

- a. Program Regulations Master of Law (M Law) Double Degree (StudO M Law Double Degree) of the Faculty of Law of the University of Zurich dated 11 December 2011,
- b. Program Regulations Master of Law (M Law) Double Degree English (StudO M Law Double Degree English) of the Faculty of Law of the University of Zurich dated 11 December 2011.

II. Transitional Provisions

§ 27 Change to the Study Program Under the New Regulations

Students who were enrolled on the German-language double degree study program in Spring Semester 2021 will change to the study program Law with effect from Fall Semester 2021.



§ 28 Transfer of Credit for Coursework Completed at UZH

¹ Coursework successfully completed between the start of the 2013 Fall Semester and Spring Semester 2021 will be taken into account on the basis of the number of ECTS credits earned under the old regulations.

² Coursework from the Bachelor's degree program under the old regulations cannot be taken into account.

§ 29 Transition Table

The transition table in the Appendix shows:

- a. Which coursework must be completed under the new regulations and
- b. Which coursework can no longer be completed at the same academic level due to the similarity of its content

III. Entry into force

§ 30 Entry into force

After approval¹ by the Extended Executive Board of the University this program regulation comes into force on 1 August 2021.



¹ Approved by the Extended Executive Board on 2 February 2021.

² Amended by the Faculty Assembly on 10 March 2021. Approved by the Extended Executive Board on 13 April 2021. Entry into force on 1 August 2021.

Appendix 3 (A3): Special Arrangements with the Partner Faculties

I. The Dickson Poon School of Law, King's College London (UK)

1. Offering

The Faculty of Law of the University of Zurich organizes a double degree Master's program as a partner faculty with the Dickson Poon School of Law, King's College London, as part of the study program of the Faculty of Law and based on the cooperation agreement of 14 December 2005.

2. Master's Degree

The Dickson Poon School of Law, King's College London, awards the academic degree of Master of Laws (LLM) from King's College London upon successful completion of a double degree Master's program.

II. Faculty of Law, The University of Hong Kong (China)

1. Offering

The Faculty of Law of the University of Zurich organizes a double degree Master's program as a partner faculty with the Faculty of Law of the University of Hong Kong as part of the study program of the Faculty of Law and based on the cooperation agreement of 3 November 2008.

2. Master's Degree

The Faculty of Law of the University of Hong Kong awards the academic degree of Master of Laws (LLM) from the University of Hong Kong upon successful completion of a double degree Master's program.

III. Faculté de Droit, de Sciences Politiques et de Gestion, University of Strasbourg (France)

1. Offering

The Faculty of Law of the University of Zurich organizes a double degree Master's program as a partner faculty with the Faculté de Droit, de Sciences Politiques et de Gestion of the University of Strasbourg as part of the study program of the Faculty of Law and based on the cooperation agreement of 23 February 2009 and on the cooperation agreement of 4 September 2023.

2. Master's Degree

The Faculté de Droit, de Sciences Politiques et de Gestion of the University of Strasbourg awards either the academic degree of "Master Droit européen, parcours Droit et politiques de l'Union européenne" or the academic degree of "Master Droit des affaires, parcours Droit bancaire et financier" or the academic degree of "Master Mention Droit des Libertés, parcours Human Rights Law in a Changing World" from the University of Strasbourg upon successful completion of a double degree Master's program.

IV. Graduate School of Law, Doshisha University (Japan)

1. Offering

The Faculty of Law of the University of Zurich organizes a double degree Master's program as a partner faculty with the Graduate School of Law of Doshisha University as part of the study program of the Faculty of Law and based on the cooperation agreement of 22 April 2014.

2. Study Program of the Faculty of Law

The Master's thesis must be written in English.

3. Master's Degree

The Graduate School of Law at Doshisha University awards the academic degree of "Master of Laws" from Doshisha University upon successful completion of a double degree Master's program.

4. Special Regulations

The following exceptional regulations apply:

- Students from Doshisha University do not pay fees upon matriculating at the University of Zurich. They pay fees at Doshisha University for the duration of the double degree program.
- Students from the University of Zurich do not pay any fees at Doshisha University during their stay there; instead, they pay the fees defined by the University of Zurich to the University of Zurich.
- Students from Doshisha University begin the double degree Master's program in the Spring Semester. They attend the first semester of the double degree Master's program at Doshisha University, the second and third semester at the University of Zurich, and the fourth semester at Doshisha University.

V. Amsterdam Law School, University of Amsterdam (Netherlands)

1. Offering

The Faculty of Law of the University of Zurich organizes a double degree Master's program as a partner faculty with the Amsterdam Law School of the University of Amsterdam as part of the study program of the Faculty of Law and based on the cooperation agreement of 9 November 2018.

2. Master's Degree

The Amsterdam Law School of the University of Amsterdam awards the academic degree of Master of Laws (LLM) from the University of Amsterdam upon successful completion of a double degree Master's program.

VI. Berkeley Law School, University of California (USA)

1. Offering

The Faculty of Law of the University of Zurich organizes a double degree Master's program as a partner faculty with the Berkeley Law School of the University of California as part of the study program of the Faculty of Law and based on the cooperation agreement of 6 November 2017.

2. Master's Degree

The Berkeley Law School of the University of California awards the academic degree of Master of Laws (LL.M.) from the Berkeley School of Law of the University of California upon successful completion of a double degree Master's program.

3. Special Regulations

The following exceptional regulations apply:

- The study program at the Faculty of Law of the University of Zurich is designed to consist of two standard semesters of study. Students from the Faculty of Law of the University of Zurich either spend one year (option A) or attend two 10 or 13-week summer courses (option B) at the partner faculty.
- Option A lasts for one calendar year. The program begins in January and ends in December. The students spend the summer semester in Berkeley, while the Spring and Fall Semesters take place online and part-time.
- Under option B, the students take two successive 10 or 13-week courses. The program begins in May and ends in August.
- Under option B, the exams at the University of Zurich may be held outside the regular examination periods. The students must apply to take the respective exams outside the regular examination period. They will be informed about the examination dates no later than two weeks before the exams are due to take place.
- Students from the Berkeley Law School do not pay any fees to the University of Zurich during their stay there. During the time they are matriculated at the Berkeley Law School, students from the University of Zurich pay the fees that the Berkeley Law School set for the respective option.

VII. Faculteit der Rechtsgeleerdheid, Maastricht University (the Netherlands)

1. Offering

The Faculty of Law of the University of Zurich organizes a double degree Master's program as a partner faculty with the Faculteit der Rechtsgeleerdheid of Maastricht University as part of the study program of the Faculty of Law and based on the cooperation agreement of 12 October 2007.

2. Master's Degree

The Faculteit der Rechtsgeleerdheid of Maastricht University awards the academic degree of Master of Laws (LL.M.) from the Faculteit der Rechtsgeleerdheid upon successful completion of a double degree Master's program.

3. Special Regulations

The following exceptional regulations apply:

- Students from the Faculteit der Rechtsgeleerdheid of Maastricht University do not pay fees upon matriculating at the University of Zurich. They pay the fees set by the Faculteit der Rechtsgeleerdheid of Maastricht University to the Faculteit der Rechtsgeleerdheid of Maastricht University for the duration of the double degree Master's program.
- Students from the University of Zurich do not pay any fees to the University of Zurich during their stay at the Faculteit der Rechtsgeleerdheid of Maastricht University; instead, they pay the Faculteit der Rechtsgeleerdheid of Maastricht University the fees it sets for EU students.

VIII. Faculteit der Rechtsgeleerdheid, KU Leuven (Belgium)

1. Offering

The Faculty of Law of the University of Zurich organizes a double degree Master's program as a partner faculty with the Faculteit der Rechtsgeleerdheid of KU Leuven as part of the study program of the Faculty of Law and based on the cooperation agreement of 18 June 2014.

2. Study Program of the Faculty of Law

In addition to the elective modules required for the respective study program, students complete either the core elective module "Legal Theory", the core elective module "Legal Methods" or the core elective module "Legal Sociology". In return, they must complete one module worth 6 ECTS credits less from the module group "various module groups".

Students may participate in the European Law Moot Court and under the conditions specified in § 43 RVO RWF, have 12 ECTS credits counted as their Master's thesis. If they advance to the final phase, students may have 6 ECTS credits counted as the core elective module "Legal Theory," the core elective module "Legal Sociology," or the core elective module "Legal Methods."

Students may participate in the Willem C. Vis Moot (Vienna Moot Court) and, under the conditions specified in § 43 RVO RWF, have 12 ECTS credits counted as their Master's thesis and the remaining 6 ECTS credits counted as the core elective module "Legal Theory," the core elective module "Legal Sociology," or the core elective module "Legal Methods."

3. Master's Degree

The Faculteit der Rechtsgeleerdheid of KU Leuven awards the academic degree of Master of Law from KU Leuven upon successful completion of a double degree Master's program.

IX. Faculty of Law, University of Johannesburg (South Africa)

1. Offering

The Faculty of Law of the University of Zurich organizes a double degree Master's program as a partner faculty with the Faculty of Law of the University of Johannesburg as part of the study program of the Faculty of Law and based on the cooperation agreement of 4 February 2021.

2. Master's Degree

The Faculty of Law of the University of Johannesburg awards the academic degree of Master of Laws (LLM) from the University of Johannesburg upon successful completion of a double degree Master's program.

3. Special Regulations

The following exceptional regulations apply:

- Students from University of Johannesburg can start the double degree Master's program in the Spring Semester.
- Students from University of Johannesburg do not pay fees upon matriculating at the University of Zurich. They pay fees to the University of Johannesburg for the duration of the double degree Master's program.
- Students from the University of Zurich do not pay any fees to the University of Johannesburg during their stay there; instead, they pay the fees defined by the University of Zurich to the University of Zurich.

X. Benjamin N. Cardozo School of Law – Yeshiva University (USA)

1. Offering

The Faculty of Law of the University of Zurich organizes a double degree Master's program as a partner faculty with the Benjamin N. Cardozo School of Law – Yeshiva University as part of the study program of the Faculty of Law and based on the cooperation agreement of 25 April 2024.

2. Master's Degree

The Benjamin N. Cardozo School of Law – Yeshiva University awards the academic degree of Master of Laws (LL.M.) from the Benjamin N. Cardozo School of Law – Yeshiva University upon successful completion of a double degree Master's program.

XI. Chicago-Kent College of Law (USA)

1. Offering

The Faculty of Law of the University of Zurich organizes a double degree Master's program as a partner faculty with the Chicago-Kent College of Law as part of the study program of the Faculty of Law and based on the cooperation agreement of 17 December 2024.

2. Master's Degree

The Chicago-Kent College of Law awards the academic degree of Masters of Laws (LL.M.) from the Chicago-Kent College of Law upon successful completion of a double degree Master's program.

XII. The University of Edinburgh, Scotland (UK)

1. Offering

The Faculty of Law of the University of Zurich organizes a double degree Master's program as a partner faculty with the University of Edinburgh as part of the study program of the Faculty of Law and based on the cooperation agreement of 4 June 2025.

2. Master's Degree

The University of Edinburgh awards either the academic degree of "LL.M." or "MSc" from the University of Edinburgh upon successful completion of a double degree Master's program.

XIII. Université Paris 1 Panthéon Sorbonne (France)

1. Offering

The Faculty of Law of the University of Zurich organizes a double degree Master's program as a partner faculty with Université Paris 1 Panthéon Sorbonne as part of the study program of the Faculty of Law and based on the framework agreement of 18. 06.2026.

2. Study Program at Université Paris 1 Panthéon Sorbonne

Following nomination by the University of Zurich for a specific study program at Université Paris 1 Panthéon Sorbonne, students from the University of Zurich may no longer change their study program and therefore may no longer enroll in another study program at Université Paris 1 Panthéon Sorbonne.

3. Recognition and Transfer of Credit for Coursework Completed

For students from the University of Zurich, coursework completed at Université Paris 1 Panthéon Sorbonne will be credited toward their degree by means of a general transfer of 30 ECTS credits pursuant to § 12 para. 2 RVO DD RWF.

4. Master's Degree

Université Paris 1 Panthéon Sorbonne awards either the academic degree of "Master Droit Anglais et Nord-Américain des Affaires (DANAA)," the academic degree of "Master Droit International Privé et du Commerce International (DIPCI)," the academic degree of "Master Droit Européen et International des Activités Economiques (DEIAE)," or the academic degree of "Master en Droit comparé général" upon successful completion of a double degree Master's program.

5. Special Regulations

The following exceptional regulations apply:

- Students from Université Paris 1 Panthéon Sorbonne do not pay fees upon matriculating at the University of Zurich. They pay fees at Université Paris 1 Panthéon Sorbonne for the duration of the double degree Master's program.
- Students from the University of Zurich do not pay any fees at Université Paris 1 Panthéon Sorbonne during their stay there; instead, they pay the fees defined by the University of Zurich to the University of Zurich.

- Students from the University of Zurich must enroll in an initial degree program at a French institution of higher learning and must therefore pay the student and campus life contribution (CVEC) in accordance with the applicable French legal provisions.
- Students complete the first two semesters of the double degree Master's program at the University of Zurich and the third and fourth semesters at Université Paris 1 Panthéon Sorbonne.

XIV. Faculty of Business, Economics and Law, The University of Queensland (Australia)

1. Offering

The Faculty of Law of the University of Zurich organizes a double degree Master's program as a partner faculty with the Faculty of Business, Economics and Law, The University of Queensland, as part of the study program of the Faculty of Law and based on the cooperation agreement of 7 October 2025.

2. Study Program of the Faculty of Law

For students from the University of Queensland, the double degree Master's program is offered in the study program "International and Comparative Law." Students from the University of Zurich may complete the double degree Master's program in either the study program "Law" or the study program "International and Comparative Law." The provisions of the respective study program apply to the Master's thesis.

3. Academic Degrees

The University of Queensland awards students from the University of Zurich the academic degree of "Master of Laws (LLM)" from the University of Queensland upon successful completion of a double degree Master's program. The University of Queensland awards students from the University of Queensland the academic degree of "Bachelor of Laws (Honours)" (LLB (Hons)) from the University of Queensland upon successful completion of a double degree Master's program.

4. Special Regulations

The following exceptional regulations apply:

4.1 Admission Requirements

If students from the University of Queensland do not yet meet the admission requirements pursuant to § 2 para. 1 or 2 of this program regulation when they intend to enter the double degree Master's program at the University of Zurich, they may complete a preliminary mobility semester (Student Exchange) at the Faculty of Law of the University of Zurich before definitive matriculation in the double degree Master's program (matriculation as exchange students). A statement issued by the University of Queensland confirming successful completion of the degree ("statement of completion") also constitutes proof of the degree within the meaning of § 2 para. 1 or 2. The degree certificate may be submitted at a later date.

4.2 Preliminary Mobility Semester

During the preliminary mobility semester, students from the University of Queensland complete at least 30 ECTS credits from the English-language modules offered at Master's level. Modules are selected on the basis of the study program International and Comparative Law (Appendix 1). Work on the Master's thesis may not begin until definitive matriculation in the double degree Master's program.

After completing a preliminary mobility semester, students from the University of Queensland may begin the double degree Master's program in either the Fall Semester or the Spring Semester.

4.3 Transfer of Credit

Coursework successfully completed during the preliminary mobility semester at the Faculty of Law of the University of Zurich will, after definitive matriculation in the double degree Master's program, be credited toward the double degree study program up to a maximum of 30 ECTS credits, provided that it corresponds to the standard curriculum (Appendix 1).

4.4 Fees

Students from the University of Queensland are not charged any fees by the University of Zurich for the preliminary mobility semester.

After definitive matriculation in the double degree Master's program at the University of Zurich, students from the University of Queensland pay the applicable fees at the University of Zurich.

Students from the University of Zurich do not pay any fees to the University of Zurich during their studies at the University of Queensland; instead, they pay the fees set by the University of Queensland.
